

## WEBSITE PRIVACY POLICY

Privacy Policy last updated: March 25, 2026

Family Autism Support Team, Inc. (“we,” “our,” or “us”) cares about your privacy. This Privacy Policy explains what information we collect, how we use it, and when we may share it. We may update this policy from time to time; if we do, we will update the date above. By using our website or mobile application (the “Site”), you agree to this Privacy Policy.

This policy covers information we collect on the Site and information you share with us in other ways (online, in writing, or by phone).

### **What Information Is Collected?**

We collect information that identifies you or could be used to identify you. In this policy, we call that “Personal Information.” We collect Personal Information when you choose to share it with us—for example, when you sign up to volunteer, donate, or contact us. Personal Information may include your name, address, ZIP code, phone number, birthday, demographic information, and email address.

We may also collect some information automatically when you use the Site (for example, through cookies and similar technologies). We use this information to keep the Site working, improve it, and understand how people use it.

You can usually manage cookies in your browser settings. If you block cookies, some parts of the Site may not work properly. If you use our mobile app, you can stop the app from collecting information by uninstalling it or adjusting your device privacy settings.

We do not knowingly collect Personal Information from children under 13. This Site is intended for people in the United States. If you think a child under 13 shared Personal Information with us, email us and we will take steps to delete it.

### **What Do We Do With Information?**

We use Personal Information to support the Organization’s mission—for example, to share information about programs and activities and to request and process donations.

We may share Personal Information with:

- Our related organizations (subsidiaries or affiliates), if we have any.
- Service providers who help us run the Organization and the Site.
- Analytics and search providers that help us understand and improve the Site.
- Other trusted third parties when needed to provide services you request.
- Other nonprofits for mission-related work.
- Another organization, if we are involved in a merger, acquisition, or sale of assets.

- Others for a reason we explain when you provide the information.
- Others when you tell us it's OK.

We use third-party payment services to process donations and other transactions. If you donate online, we share the information needed to complete your donation with the payment provider, and their privacy policy will apply to how they handle that information.

### **Data Security**

We use reasonable steps to help protect your Personal Information. No website or system can be completely secure, but we work to reduce the risk of unauthorized access.

### **Links to Third-Party Websites**

The Site may link to other websites (for example, payment providers or other organizations). Those sites may have different privacy practices than we do, and this policy does not cover them. Please review the privacy policy of any website you visit.
